Statement of Program Service Accomplishments

In **VictimsFirst** initial year, as a non-profit 501c3 organization, it responded to mass casualty crimes across the United States and helped behind the scenes in other facility shootings. Upon formation April 1, 2021, the organization provided support by providing guidance and aligning with the National Compassion Fund so that 100% of what is collected directly benefits the victims in cash payments.

A list of the events where VictimsFirst responded and supported in this period are listed below:

- The **FedEx Facility shooting** in Indianapolis, Indiana that occurred on April 15, 2021, where 9 people were murdered and 7 were injured.
- The **Kroger shooting** in Collierville, Tennessee, where 1 person was murdered and 12 others were injured.
- Provided trauma specialist resources for the victims of the **Mueller Manufacturing Plant shooting** in Albertville, Alabama that occurred on June 15, 2021, where 2 employees were murdered and 2 others were injured.
- Tracked victims funds and provided our National Protocol for Mass Casualty Crimes to the Amalgamated Transit Union and Working Partnerships USA for the **shooting at the Santa Clara Valley Transportation Authority (VTA)** in San Jose, California that occurred on May 26, 2021, where 9 people were murdered. The organization worked to ensure news reporting agencies utilized the No Notoriety Policy when reporting on the trial of the Parkland shooter.
- Assisted the National Compassion Fund with the Victims Fund for the **Surfside Condominium Collapse** that occurred on June 24, 2021 and left 94 people dead.
